# Demonstrate the significance of **CLEAN-**ING AND DISINFECTION POLICIES

#### Introduction

This recommendation describes the need for CLEANING AND DISINFECTION **POLICIES** in a RUMED and their significance, while explaining how they are formulated and implemented and giving examples of their content.

Note: This publication is intended as a guide to formulating/revising a cleaning and disinfection policy.

#### Significance of cleaning and disinfection policies

They are an integral part of the infection control policies and therefore have the same significance as the latter policies; see Recommendation Part 12, Zentralsterilisation 05/2020. Cleaning and disinfection policies

- are legally stipulated by the German Protection against Infection Act (IfSG) as constituting a part of the infection control policy. Subordinate regulations specify this requirement.
- are an integral part of quality management in a RUMED.
- describe sequences and work materials.
- assign competencies.
- are binding specifications for the RUMED economic operator (service instructions).
- failure to comply with these provisions may result in disciplinary action.
- describe hygiene procedures in the context of protection against infection and occupational health and safety.
- constitute the basis for verification of compliance with hygiene-related work
- serve as documentary evidence of personnel induction.
- serve as the basis for regular staff training.
- are evidence in legal disputes.

#### Include INFECTION CONTROL POLICIES

# Additionally applicable documents for cleaning and disinfection policies **INFECTION CONTROL POLICIES** such as e.g.:

- Hand hygiene
- Personal hygiene
- Surface disinfection and cleaning
  - Documentation of the implementation of cleaning and disinfection
  - Documentation of the verification of cleaning and disinfection
  - Verification of hygienic surface cleaning and disinfection, including hygiene rating
- Waste management
- Laundry supply and collection
  - Verification of the hygienic reprocessing of cleaning utensils
  - If necessary, suitability testing of presaturated cleaning utensils for surface/floor cleaning and disinfection

# Observe **QUALITY MANAGEMENT** and **OCCUPATIONAL SAFETY AND HEALTH**

Aspects of OCCUPATIONAL SAFETY AND HEALTH and of QUALITY MANAGE-**MENT** must be observed such as e.g.:

- Qualification of personnel entrusted with cleaning and disinfection
- Induction
- Operating instructions



- Safety data sheets
- Service specifications for cleaning and disinfection of buildings
- Designation of supervisors and contact persons

Specification of the STRUCTURAL QUALITY of the cleaning of buildings is a prerequisite for implementation of cleaning and disinfection policies. In general, the following tasks must be undertaken for the entire clinic/practice/facility:

- Designation of suitable rooms for reprocessing cleaning utensils, cleaning trolleys, cleaning machines
- Designation of suitable rooms/areas for storage of cleaning utensils, cleaning trolleys, cleaning machines, detergents, disinfectants
- List of the detergents and disinfectants used, while taking account of material compatibility and the dosing methods employed
- Description of the cleaning methods

The **PROCESS QUALITY** must also be specified, e.g. description of the

- Cleaning methods
- Disinfection methods
- Reprocessing methods for mops, cloths, cleaning machines
- Storage and transportation of reprocessed and of used cleaning mops, cloths, cleaning machines
- Loading cleaning trolleys
- Special services such as laundry collection and, if applicable, laundry supply

General contents of cleaning and disinfection policies

The **CLEANING AND DISINFECTION** methods to be implemented must be set out for the individual department and workplace:

| where     | Which room/working area/zone  |

| who       | RUMED or cleaning service   |

Procedure in the event of special incidents, e.g. disinfection following contamination of surfaces with pathogens not covered by the spectrum of action of the disinfectants routinely used.

Cleaning and disinfection of medical devices must be regulated in separate standard operating procedures/infection control policies.

# Formulation/updating of cleaning and disinfection policies

This is the responsibility of the **OPERATOR**.

Formulation of cleaning and disinfection policies should be delegated to SUIT-**ABLE PERSONS** within the respective establishment – primarily to e.g. infection control personnel, hospital infection control consultant, infection control staff in an office-based medical practice and, as applicable, the house-keeping management. The RUMED management must be involved in policy formulation. If building cleaning and disinfection tasks are delegated to external service providers, the latter must be consulted before finalising the policies. Cleaning and disinfection policies must be updated whenever warranted, e.g. when making changes to surface usage, to the process chemicals used or to the working methods.

Observe **CLEANING AND DISINFECTION POLICIES** in general

The **OPERATOR** is responsible Delegate the formulation of cleaning and disinfection policies to SUITABLE PERSONS

The policies must be reviewed and updated regularly in accordance with the provisions of the establishment's quality management system.

### Cleaning and disinfection policy format

Define the **FORMAT** of the cleaning and No specific **FORMAT** is defined. The tabular form has proved useful for cleaning disinfection policies and disinfection policies. Required details:

Establishment name/logo

Department/service facility/workstation

Formulation date /author

Revision date/author

Version number

Release/date/released by

**DOCUMENTARY GUIDANCE** 

#### Release of cleaning and disinfection policies

All cleaning and disinfection policies and their **UPDATES**/amendments must be released or adopted.

- Release or adoption by the hospital/clinic Infection Control Team (in accordance with the requirements of the federal state infection control regulations)
- Release by the economic operator e.g. of a medical practitioner's office, independent RUMED

## Implementation of cleaning and disinfection policies

The cleaning and disinfection policies must be **MADE KNOWN** to all staff members of the RUMED and cleaning services, i.e. they must be made available in a suitable form to every staff member.

Staff must be made aware of the cleaning and disinfection policies, new employees have to get an induction and all staff members must receive training at regular intervals and after updates.

The training frequency is determined by the federal state regulations and the establishment's quality management policies. **TRAINING** must be documented.

Acknowledgement of the plans must be personally confirmed by all those named therein.
